NOTES:

- A. PMS A-Girls Rugby games on the following dates: Tuesday, April 28 – no use until 7:30 p.m. Practice on June 2 until 6:30 p.m.
- B. High school rugby on Elm Creek B in May/June until 8:00 p.m. Tuesday – Friday (rugby goal posts on field). Prior to June, space for practice only.
- C. High School Lacrosse on Elm Creek A in April/May until 7:00 p.m. most nights. (No use on Tuesday, April 28; Thursday, April 30; Friday, May 15 – lacrosse games until 8:30 p.m.)
- D. Elm Creek A may not be lined for soccer until June – prior to that, use for space only.
- E. No use of Plymouth Creek A or B on Wednesday, July 1 – Music in Plymouth.
- F. WEMS/Ridgemount school function until 5:30 p.m. on Friday, May 29.
- G. MN Thunder Academy Tournament – May 15-17.
- H. PSA Tournament – June 19-21.
- I. For games, all fields available to use. Schedules worked out with the 3 associations.
- J. Athletic Association Numbers Form must be filled out and submitted.
- K. Must get practice and all game schedules.
- L. Permit is tentative and subject to change.

The undersigned agrees to assume full responsibility for the care of the reserved facilities and the behavior of participants during that activity. He/she further agrees to abide by the following rules:

- 1. Sufficient adult supervision to be present at all times while facility is in use.
- 2. NO intoxicating beverages or 3.2 beer are permitted in any park or on public grounds.
- 3. NO tobacco products permitted in any park or on public grounds.
- 4. Activities are not permitted on park grounds after 10 p.m. (9 p.m. Sunday), or before 8 a.m. (10 a.m. Sunday).
- 5. Special arrangements must be made for use of lights at a field.
- 6. The City of Plymouth reserves the right to cancel a permit at any time when:
 - ♦ Weather doesn't permit field use.
 - ♦ Maintenance is required on a field.
 - ♦ That group has abused the privileges of their permit.
- 7. Any damage occurring during a group's use will be that group's responsibility to repair.
